#### **Project Description:**

Energy Savings Performance Contracting (ESPC) is a budget-neutral approach to make building improvements that reduce energy and water use and increase operational efficiency. By partnering with an energy service company (ESCO), a facility owner can fund today's facility upgrades with tomorrow's energy savings—without tapping into capital budgets.

City of Boston issued a contract to Honeywell (ESCO), who conducted a preliminary audit analysis of 266 facilities which identified potential energy conservation measures (ECM's).

The City of Boston is currently in agreement with Honeywell to install several energy conservation measures throughout 14 buildings within 5 city departments. As part of a pilot phase, Phase 1 contains lighting upgrades, the installation of low-flow water fixtures, HVAC upgrades, Solar PV installations, building automated controls system upgrades, building envelope improvements, etc.

Honeywell will implement agreed-upon ECMs, and then monitor energy savings through measurement and verification. Buildings slated to receive upgrades as part of Phase 1: Tobin Community Center, Shelburne Community Center, Roslindale Community Center, Flaherty Pool, BPD Headquarters, A15 - Police Station, D4 - Police Station, William J. Devine Golf Course, Engine 32, Engine 9, Copley Library, Lower Mills Library, Brighton Library and Hyde Park Library.
