# **Boston OD2A**

The Office of Recovery Services (ORS) leads substance use policy and strategy for the Boston Public Health Commission. ORS is implementing Boston OD2A, working closely with government and community partners. These collaborators include the Massachusetts League of Community Health Centers, Grayken Center for Addiction at Boston Medical Center, and the Institute for Community Health.

**Boston is receiving** \$1.3M per year for 5 years

This \$6.5M will expand harm reduction, enhance clinical practices, and boost data operations.



# **Funding Background**

The Centers for Disease Control funds Overdose Data to Action: Limiting Overdose through Collaborative Actions in Localities. The grant expands evidence-based interventions targeted at reducing overdoses in cities and counties, leveraging data analysis to better serve communities at high risk. Recipients work closely with the CDC to implement tailored strategies, while also forming a network across the US, learning together and sharing resources.

## **Key Activities**

#### 01 Helping Communities Navigate Treatment

Funding three substance use navigators in community health centers to connect people to services and evidence-based medicine

#### 02 Distributing More Naloxone

Hiring a new staffer to bring the overdose-reversing medication to more communities, exploring creative ideas and partnerships

#### 03 Training More People on Overdose Rescue

Raising capacity throughout the public and targeting service providers who work directly with people at risk of overdose

# 04 Advancing the Healthcare Workforce

Training medical professionals about substance use trends, barriers to care, stigma, and more

# 05 Data Dashboard

Merging and visualizing data about opioid use and overdose in Boston, informing shared response

# **Target Populations**

Community needs assessments and public health science inform the Boston OD2A focus on four populations. This project will prioritize individuals who are at increased risk of overdose.

- Black
  Experiencing homelessness
- Latinx Individuals re-entering from incarceration
